

## Introduction

Tamil Nadu is one of the mega bio-diverse states of the country, being endowed with a bounty of rich biodiversity right from coastal marine ecosystems in the Gulf of Mannar to terrestrial evergreen forests in the Western Ghats. Out of the 16809 species of flowering plants in India, Tamil Nadu ranks first in species richness with 5674 taxa. The faunal diversity is also equally impressive which includes 165 species of fresh water fishes, 76 species of amphibians, 177 species of reptiles,454 species of birds and 187 species of mammals.


The rich biodiversity of the state is faced with increasing pressure on account of habitat destruction, degradation, fragmentation, overuse of resources, invasion of alien species, pollution and climate change which threatens to push a number of endemic species to the verge to extinction and seriously impact the ecosystem services which are vital to human existence and well-being. While efforts at biodiversity conservation date back to times immemorial, they have been flagship species centric and area-based approaches, at best. The signing of the Convention on Biological Diversity (CBD) in 1992 signified the world-wide dawning of the realisation that biodiversity has to be conserved and sustainably used across landscapes.

Towards fulfilment of its national commitments as a signatory to the treaty (CBD), India enacted the Biological Diversity Act in the year 2002. Established in 2008 as per section 22 of the Biodiversity Act 2002, the Tamil Nadu Biodiversity Board has come a long way. In course of its journey spanning a period of 13 years, the Board has ensured the constitution of Biodiversity Management Committees across the state and preparation of People's Biodiversity Registers, organized training and capacity building programmes for stakeholders involved in the Access and Benefit Sharing (ABS) process, notably the Forest Range Officers (FROs), Block Development Officers (BDOs), District Forest Officers (DFOs) and companies using bio-resources.

Be that as it may, there is still a long way to be traversed before the BMCs are strengthened to become decentralised, grassroot level, self-sustaining institutions for conserving biodiversity on a sustainable basis through community participation, and biodiversity conservation becomes institutionalised and mainstreamed into the planning and programme implementational frameworks of the State. The Board is poised to walk these infant institutions through their teething phase on the path to the envisioned goals, extending necessary handholding support as required.

#### Genesis of the Board

The Tamil Nadu Biodiversity Board was constituted on 29 April 2008 vide G.O. (Ms) No. 38 Environment and Forests (FR-5) Department under Section 22 of the Biological Diversity Act, 2002, with the Hon'ble Minister for Forests as the Chairperson of the Board. Since its constitution, senior IFS officers have been appointed as the Secretaries to the Board. The Tamil Nadu Biodiversity Rules were notified on 9 November 2017 through G.O. Ms. No. 137, Environment and Forest (FR-5). The Rules came into effect from 6 December 2017 after which the Board's activities gathered momentum to achieve new heights.



#### **Functions of the Board**

Section 23 of the Biological Diversity Act 2002 states the following functions of the State Biodiversity Board:

- a. Advise the State Government, subject to any guidelines issued by the Central Government, on matters relating to the conservation of biodiversity, sustainable use of its components and equitable sharing of the benefits arising out of the utilization of biological resources;
- b. Regulate by granting of approvals or otherwise, requests for commercial utilization or bio-survey and bio-utilization of any biological resource by Indians;
- c. Perform such other functions as may be necessary to carry out the provisions of this Act or as may be prescribed by the State Government.

Rule 13 of the Tamil Nadu Biological Diversity Rules 2017 states the following 27 functions:

- i. lay down the procedure and guidelines to regulate the activities provided under Section 7 of the Act;
- ii. advise the Government, subject to any guidelines issued by the Central Government, on any matter concerning conservation of biodiversity, sustainable use of its components and fair and equitable sharing of benefits arising out of the use of biological resource and knowledge;
- iii. provide livelihood support to those villagers, who have shifted or are in the process of shifting from unsustainable livelihoods to sustainable livelihoods or as Trekking Service Providers;
- iv. promote and strengthen individuals and institutions who are already working towards conservation, sustainable use and equitable benefit sharing of biological resources;
- v. provide technical assistance and guidance to various departments of the Government in connection with implementation of provisions of the Act;
- vi. regulate by granting of approvals or otherwise requests for commercial utilisation or bio-survey and bio-utilisation of any biological resources under the Act by Indians;
- vii. facilitate updating and implementation of State Biodiversity Strategy and Action Plan;
  - viii. commission studies and sponsor investigations and research;
- ix. engage consultants, for specific period, not exceeding three years, for providing technical assistance to the Board in the effective discharge of its functions;
- x. collect, compile and publish technical and statistical data, manuals, codes or guides relating to conservation of biological diversity, sustainable use of its components and fair and equitable sharing of benefits arising out of the use of biological resource and knowledge;

- xi. organise through mass media, a comprehensive programme regarding conservation of biological diversity, sustainable use of its components and fair and equitable sharing of benefits arising out of the use of biological resources and knowledge:
- xii. plan and organise training of personnel engaged or likely to be engaged in programmes for the conservation of biological diversity and sustainable use of its components;
- xiii. prepare the annual budget of the Board incorporating its own receipts and also the funds or grants from the Central Government, State Government and National Biodiversity Authority:

Provided that such allocation by the Central Government or State Government or National Biodiversity Authority shall be operated in accordance with the budget provisions approved by the Central Government or State Government or National Biodiversity Authority, as the case may be;

- xiv. approve the en-bloc sanction of the annual budget and work programme;
- xv. recommend to the Government, for creation of posts of the officers and employees of the Board for effective discharge of the functions by the Board and to create such posts, provided that no such post whether permanent, temporary or of any nature, shall be created without prior approval of the Government;
- xvi. approve the method of recruitment to the officers and employees of the Board;
- xvii. take steps to build up database and to create information and documentation system for biological resources and associated traditional knowledge through biodiversity registers and electronic databases, to ensure effective management, promotion and sustainable use;
- xviii. give advice and directions to the local bodies, Biodiversity Management Committees in writing for effective implementation of the Act and to facilitate their meaningful participation in all measures relating to conservation, sustainable use and equitable benefit sharing;
- xix. report to the Government about the functioning of the Board and implementation of the Act and the rules made thereunder;

xx. devise methods to ensure protection of rights including intellectual property rights over biological resources and associated knowledge including systems of maintaining confidentiality of such information as appropriate, including the protection of the information recorded in People's Biodiversity Registers;

xxi. sanction grants-in-aid and grants to Biodiversity Management Committees for specific purposes;

xxii. undertake physical inspection of any activity or work to check whether it is in accordance with the provisions of the Act;

xxiii. ensure that biodiversity and biodiversity-dependent livelihoods are integrated into all sectors of planning and management, and at all levels of planning from local to State, to enable such sectors and administrative levels to contribute effectively to conservation and sustainable use;

xxiv. award individually or as a group, or both for innovation and contribution in the biodiversity sector of the State;

xxv. formulate guidelines to the settlement of disputes between the Biodiversity Management Committees and to evaluate the performance of the Biodiversity Management Committees and annually reward the best performing Biodiversity Management Committee at each level in the State;

xxvi. recommend in consultation with the local bodies for notifying the areas of biodiversity importance as biodiversity heritage sites under sub-section (1) of Section 37 of the Act and for the management and conservation of the heritage sites;

xxvii. perform such other functions as may be necessary to carry out the provisions of the Act or as may be assigned or directed by the Government from time to time.



## **Expert Committee on Access & Benefit Sharing**

TNBB receives applications for access to biological resources under several sections of the Act, either directly or through the National Biodiversity Authority (NBA). This Committee processes these applications to either recommend or return them. Once recommended, ABS agreements are signed between the applicant and TNBB to ensure that the received benefits are shared with the providers of biological resources.

#### Expert Committee on "BMC Constitution and Documentation of PBRs"

Biodiversity Management Committees (BMCs) are the ground-level institutional structures formed under the Biological Diversity Act, 2002. BMCs have important roles and functions under the Act, such as ensuring local biodiversity conservation, sustainable use of bio-resources within their jurisdiction and the documentation of People's Biodiversity Registers (PBRs) which is a dynamic record of all biological resources and associated traditional knowledge and knowledge holders within the jurisdiction of the BMCs. This Committee oversees the constitution of BMCs and the preparation of PBRs by BMCs. It also supports BMCs with their functioning, through trainings and workshops as required.

# **Board Meetings**

#### Eighth Meeting of the Tamil Nadu Biodiversity Board

The eighth Meeting of the Tamil Nadu Biodiversity Board was held on 18th September 2019 at the Secretariat, Chennai.

Meeting highlights and key decisions

- Infrastructural development and capacity building initiatives for at least one Biodiversity Management Committee in each district In this regard 90 numbers of Model BMCs were identified at the Block level..
- Board noted that International Biodiversity Day 2018 celebrations had been held in all districts of Tamil Nadu in well organized func tions. Painting, Quiz, poster and debate competition had been held for the students along with awareness and cleaning campaigns.
- A Bank account was opened in the name "Tamil Nadu Biodiversity Fund" in Indian Bank, Medavakkam Branch.
- It was decided to appoint the Tamil Nadu Agricultural University (TNAU), Coimbatore, Tamil Nadu veterinary and Animal Science University (TANUVAS), Chennai and TAMPCOL, Chennai as "Knowledge Partners" for the preparation of PBRs in Tamil Nadu State and set up a "Special cell" at TNBB Office involving the representatives of Knowledge Partners (KP) to plan and take up field / documenting works on a "Mission Mode". It was also decided to co-opt any expert or department, as and when necessary, whose contributions would enrich the quality of PBRs in consultation with the Secretary, TNBB.
- The Board accepted the proposal to appoint one State DCF and one ACF from the Forest Department on deputation for the purpose of strengthening the technical capability of the board. It was also agreed to strengthen the TNBB by deputing Technical officers from Agriculture, Horticulture, Animal Husbandry, Industries and TAMPCOL in the Rank of Assistant Directors.
- Proposals may be submitted to shift the TNBB office building to a suitable location, to post ministerial staff, hire technical consultants and subject matter specialists and also to provide sufficient budgetary where withal for the optimal functioning of the Board.
- The Chairman instructed the TNBB to send a suitable proposal to the Government to reduce the Application fee for ABS Form-1 submission from Rs 10,000 to Rs 1,000.

#### **Biodiversity Management Committees**

Implementation of Biological Diversity Act, 2002 is carried out by a three tier mechanism with National Biodiversity Authority at the National Level, State Biodiversity Boards at State Level and Biodiversity Management Committees (BMC) at Local Level.

Biodiversity Management Committees are the grass root level institutions that are responsible to carry out necessary works to fulfil the primary objectives of the Biological Diversity Act, 2002 i.e., Conservation of Biological Diversity, Sustainable use of its Components and Fair and Equitable Sharing of Benefits arising out of use of Biological Resources. Hence constituting and strengthening these committees is inevitable for successful implementation of mandates of the Act.

In this process, the Tamil Nadu Biodiversity Board has completed constituting Biodiversity Management Committees at all levels of local bodies (Corporation, Municipality, Town Panchayat, District Panchayat, Block Panchayat and Village Panchayat) and is in the process of strengthening them to make these institutions self-sustainable.

#### People's Biodiversity Register

#### Preparation

As per the Biological Diversity Act, 2002, Biodiversity Rules, 2004 and Tamil Nadu Biodiversity Rules, 2017, it is mandated that every Biodiversity Management Committee shall prepare a People's Biodiversity Register. In this regard, the Tamil Nadu Biodiversity Board has successfully facilitated the completion of preparation of PBRs of all the BMCs in the State. The activities pertaining to preparation of PBRs in the state during the time period of April 2019 – March 2021 are as follows:

In the 8th Board Meeting on 18.09.2019, it was resolved that the following departments / institutions / organizations were chosen as Knowledge Partners for preparation of PBR in the state of Tamil Nadu.

Subsequently, by 31.01.2020, 1049 Peoples Biodiversity Registers (664 Urban BMCs + 385 Rural BMCs) were completed. A National Level Monitoring Committee visited the Tamil Nadu Biodiversity Board on 24.02.2020 and 25.02.2020 to oversee the quality of People's Biodiversity Registers.

#### Access and Benefit Sharing (ABS)

Tamil Nadu Biodiversity Board receives applications for access to bio-resources under two sections of the Biological Diversity Act, 2002- Section 3 and Section 7. Users who are non-Indians or organisations with non-Indian participation submit their requests for access to bio resources to the National Biodiversity Authority (NBA) under Section 3, whereas users or user organisations registered in India apply directly to the respective State Biodiversity Board (TNBB). NBA forwards applications under Section 3 to TNBB for their recommendations. NBA also forwards applications under Section 6 of the Biological Diversity Act, 2002 dealing with intellectual property rights to TNBB when necessary. TNBB also receives ABS applications as per Rule 15 of Tamil Nadu Biodiversity Rules, 2017. Under this Rule, TNBB has received 5 Form-1 applications and these ABS applications are being processed. The following table depicts the details of applications received and processed as well as the funds received and distributed.

#### **GIZ-ABS Partnership Project**

#### **Objectives**

The ABS Partnership project aimed at strengthening the capacity of the National Biodiversity Authority, State Biodiversity Boards, Biodiversity Management Committees in Maharashtra, Tamil Nadu and Uttarakhand as well as creating awareness among commercial users of biological resources and associated traditional knowledge for the effective implementation of ABS mechanisms under the Biological Diversity Act 2002, in keeping with India's commitments under Nagoya Protocol on ABS.

#### **Key achievements**

- The project has developed communication strategy through Knowl edge-Attitude-Practice (KAP) analysis of 10 key stakeholders in the ABS process which includes, the Biodiversity Management Committees (BMC), commercial users of biological resources, Forest Department, legal professionals etc;
- Several capacity development trainings and workshops were conducted in Tamil Nadu for line department officials, District Forest Officers, Block Development Officers, Forest Range Officers, BMCs etc, with participation of more than 2000 people;
- Methodology for Training of Trainers (ToT) for operationalisation of BMCs was pilot tested and 50 district trainers have been trained on vari ous aspects of BMC functions and documentation of People's Biodiver sity Registers;
- Good practice case studies of ABS from the use of biological resources from forests, agriculture, animal-based derivative (snake venom) have been developed to showcase the ABS process and to serve as models for ABS compliance;
- Project has been instrumental in establishment and capacity develop ment of 12 BMCs in 10 districts of Tamil Nadu. Model People's Biodiversity Registers have been documented and validated (location of pilot BMCs given in fig.1)
- Dialogue with businesses on ABS compliance was held in Chennai, Madurai and Nagercoil.

#### Prosecutions launched and convictions secured

1. BDOR.No 1/2019 Dated 15/05/2019

District: Thiruvallur

Forest Division: Thiruvallur Forest Division

Forest Range: Gummudipoondi Range

An offence was booked under the Biological Diversity Act, 2002 on 15.05.2019 for illegal transportation of Polychaet (சிவப்புநிற உவர் நீர் பண்புழு) since obtaining biological resources for commercial utilization, or bio survey or bio utilization for commercial utilization without giving prior intimation to State Biodiversity Board is a crime in accordance with Section 7 of the act and subsequently the offence was booked under Section 7 and Section 55(2) of the Biological Diversity Act, 2002.

The accused was transporting Polychaet(சிவப்புநிற உவர் நீர் மண்புழு) in 20 jute bags in a Toyota Innova car in the Gummudipoondi – Chennai Highway on 14.05.2019. At around 4:30 pm on 14.05.2019, the vehicle mentioned above was stopped for routine checking by the Sub-Inspector at the Police Check Post near Elavur, when it was found that illegal transportation was being done. Subsequently, the accused were arrested and remanded in the Ponneri Sub Jail and the bio-resource (Polychaet) along with the car and other materials (Cell phones and SIM cards) were confiscated. The bio-resource (Polychaet) captured was destroyed in line with order of court arbitrator. Further investigations are being made in this regard.

#### 2. BDOR.No 2/2019 Dated 22/05/2019

District: Thiruvallur

Forest Division: Thiruvallur Forest Division

Forest Range: Gummudipoondi Range

An offence was booked under the Biological Diversity Act, 2002 on 22.05.2019 for illegal transportation of Polychaet(சிவப்புநிற உவர் நீர் மண்புழு) since obtaining biological resources for commercial utilization, or bio survey or bio utilization for commercial utilization without giving prior intimation to State Biodiversity Board is a crime in accordance to Section 7 of the act and subsequently the offence was booked under Section 7 and Section 55(2) of the Biological Diversity Act, 2002.

The accused was transporting 30 Kgs of Polychaet(சிவப்புநிற உவர் நீர் மண்புழு) in 5 thermocol boxes in a Mahindra TUV 300 Plus car in the Gummudipoondi – Chennai Highway on 21.05.2019. At around 4:00 pm on 21.05.2019, the vehicle mentioned above was stopped for routine checking by the Sub-Inspector at the Police Check Post near Elavur, when it was found that illegal transportation was being done.

Subsequently, the accused were arrested and remanded in the Ponneri Sub Jail and the bio-resource (Polychaet) along with the car and other materials (Cell phones and SIM cards) were confiscated. The bio-resource (Polychaet) captured was destroyed in line with order of court arbitrator. Further investigations are being made in this regard.

#### 3. BDOR.No 3/2019 Dated 15/09/2019

District: Thiruvallur

Forest Division: ThiruvallurForsest Division

Forest Range: Gummudipoondi Range

An offence was booked under the Biological Diversity Act, 2002 on 15.09.2019 based on the information that Polychaet(சிவப்புநிற உவர் நீர் மண்புழு) was found discarded in 23 polythene bags in a Mahindra Xylo car. Since obtaining biological resources for commercial utilization, or bio survey or bio utilization for commercial utilization without giving prior intimation to State Biodiversity Board is a crime in accordance to Section 7 of the act, an offence was booked under Section 7 and Section 55(2) of the Biological Diversity Act, 2002.

On 14.09.2019, the Gummudipoondi Range office was informed by Kavarapettai Police Sub Inspector that Polychaet(சிவப்புநிற உவர் நீர் மண்புழு) were found in 23 polythene bags in a Mahindra Xylo car. There were no accused found in the car and hence no one was arrested in this regard. The bio-resource (Polychaet) along with the car was confiscated. Further investigations are being made in this regard.

#### 4. BDOR.No.1/2019 dated 11/11/2019

District: Ramanathapuram

Forest Division: Gulf of Mannar Marine National Park

Forest Range: Mandapam Wildlife Range

An offence was booked under the Biological Diversity Act, 2002 on 15.09.2019 based on the information that Lugworms (பாலி புழுக்கள்) were being packed and attempted to smuggle in Valayarvadi region of Mandapam. Since obtaining biological resources for commercial utilization, or bio survey or bio utilization for commercial utilization without giving prior intimation to State Biodiversity Board is a crime in accordance to Section 7 of the Act, an offence was booked under Section 7 and Section 55(2) of the Biological Diversity Act, 2002.

The accused were packing the 158 Kgs of Lugworms (பாலி பழுக்கள்) in thermocole boxes and polythene bags in a coconut farm in Valayarvadi region of Mandapam. A team from Mandapam Wildlife Range inspected the region based on a tip-off and surrounded the accused red handed and arrested them. The materials were confiscated. Later the confiscated materials were destroyed in presence of court arbitrator.
