Agenda 3: Constitution, strengthening and functioning of the Block level Biodiversity Management Committees (BMCs)

- 1. The Rural Development & Panchayat Raj Department has taken active action with the district level administration in the state to form BMCs at the Block level and 385 Nos. of BMCs were constituted in the state. The list of BMCs constituted is provided in Annexure 3.
- 2. As per the Principal Secretary to Government, Municipal Administration and Water Supply (MA.IV) Department letter No. 7767/MA.IV(2)/2018-7, dated 10.10.2018, all the Urban Local Bodies (124 Municipalities, 11 Municipal Corporations, 528 Town panchayats and one Greater Chennai Corporation) under control of the Municipal Administration and Water Supply (MA.IV) Department have completed constitution of 664 BMCs.

In total 1049 BMCs (385 + 664) BMCs have been formed in Tamil Nadu.

Agenda 4: Strengthening the functioning of the BMCs

A. Recommendation of appointing the Forest Range Officer as Secretary of BMC

As per Rule 20(9) of the Tamil Nadu Biological Diversity Rules, 2017, the Government on the recommendation of the Board may designate an officer as the Secretary of the Biodiversity Management Committee. The Secretary of the BMC will assist/guide the BMC in the tasks/role listed out in Rule 21, 22 and 23 of the Tamil Nadu Biological Diversity Rules, 2017.

As per the Director, Directorate of Rural Development and Panchayat Raj Chennai Letter No. 8164/2018PRI 4-1 dated 07.02.2018, instructions were issued to all Collectors to form BMCs at the Block level with the Range Officer from Forest department functioning in the Block to act as Secretary of the BMC.

Hence, it is requested that the Board may recommend the Forest Range Officer functioning within/close to each Block to be designated as the Secretary of the concerned Biodiversity Management Committee.

The list of Range Officers to be designated as the Secretaries of the various BMCs is provided in Annexure 3.

B. Recommendation of appointing the DFO in each district as Nodal Officer for BMCs

As per Rule 20(10) of the Tamil Nadu Biological Diversity Rules, 2017, the Government on the recommendation of the Board may designate Nodal officer for each district to oversee the various matters of the Biodiversity Management Committees (BMC) within the district.

In this regard proposals have been submitted to the Government by PCCF & CWLW in ref. No. WL4/37326/2016 dated 28.05.2018 (Annexure 1).

The functions of the Nodal officer are proposed as follows:

- i) Oversee the functioning of the Biodiversity Management Committees in their district
- ii) Supervise the implementation of the tasks allotted to the Secretary (Forest Range Officers) of the Biodiversity Management Committees in their district.
- iii) Coordinate with the officers of the line departments in providing necessary guidance to the BMCs in their district for carrying out the roles and responsibilities as listed in the Tamil Nadu Biological Diversity Rules, 2017.
- iv) Providing necessary guidance to the BMC in the preparation of the People's Biodiversity Register.
- v) Report to the District Collector regarding the above every month.
- vi) Report to the Tamil Nadu Biodiversity Board and carry out the tasks and responsibilities entrusted to them by the Board.

In the Government letter No: 10464/FR.5/2018-2 E&F Department Dated: 06.08.2018, it has been directed to place this proposal before the Board during its meeting and send the recommendation of the board to the Government.

Apart from the above reasons and as the Forest Range Officer has also been proposed to be the Secretary of the BMCs, it is requested that the Board may recommend the District Forest officer in each district as the Nodal Officers for each district.

The list of DFOs recommended as Nodal Officers by the PCCF is provided in Annexure 1.

C. Formation of Technical Support Group (TSG) in each district consisting of people having vast expertise in the Biodiversity issues to guide Biodiversity Management Committee.

The BMC requires considerable technical support in documenting the Biodiversity in the areas of its jurisdiction and as per the 'Guidelines for Operationalization of Biodiversity Management Committees' issued by the National Biodiversity Authority, it has been mentioned that the BMC formation can also possibly be mediated through Technical Support Groups (TSG). The TSG is expected to comprise officials/ institutions/ people of excellence and expertise in the biodiversity issues at local level and should guide the BMC in its operation. The Technical Support Group is to be formed at district level including representative from the department of Forests, Agriculture, Horticulture, Veterinary and Fishery, Local Educational and Research Institutions, Autonomous District Councils, Non-Governmental Organizations, Herbal Practitioner etc., based on the local conditions.

Accordingly, it is requested that Technical Support Groups may be constituted in each district of the State with the following objectives:

- (i) The BMC formation shall be assisted by the TGS.
- (ii) The People's Biodiversity Register shall be maintained, authenticated and validated by the Biodiversity Management Committees with the assistance/guidance of the Local TSG.
- (iii) The TSGs established shall assist BMCs with regard to collection fee, benefit sharing and management of heritage sites, sacred groves and water bodies.
- (iv) The TSG shall assist the BMC in listing local names of flora, fauna, traditional knowledge relating to flora and fauna, and current practices of communities regarding conservation within its territorial jurisdiction, to be included in the PBR.

A Technical Support Group may be constituted with following members in each district:

- 1. Nodal officer from the Forest Department.
- 2. Joint Director, Agriculture Department
- 3. Joint Director, Horticulture Department
- 4. Joint Director, Fisheries Department
- 5. Joint Director, Animal Husbandry Department
- 6. Medical Officer, Siddha Medicines, Health Department
- 7. District Sericulture Officer, Sericulture Department
- 8. Senior Lecturer / Professor in Botany from local College / University
- 9. Senior Lecturer / Professor Zoology from local College / University

Accordingly, proposals have been sent to Government for the formation of Technical Support Group in each district vide PCCF and Chief Wildlife Warden Ref No. WL4/26945/2017 dt: 20.07.2017 (copy enclosed Annexure 2). In the Government letter No: 10464/FR.5/2018-2 E&F Department Dated: 06.08.2018, it has been directed to place this proposal before the Board during its meeting and send the recommendation of the board to the Government.

Hence, it is requested that the Board may recommend the constitution of Technical Support Groups (TSG) in each district.

Agenda 5: Biodiversity Management Committees to be developed as Model BMCs

The Tamil Nadu Biodiversity Board is currently developing guidelines to guide the overall functioning of Biodiversity Management Committees from an implementation perspective and the Standard Operating Procedures for activities to be undertaken by the BMCs. The Board in close coordination with the District Nodal Officers will be shortly undertaking infrastructural development and capacity building initiatives for at least one Biodiversity Management Committee in each district of the state to be developed as Model BMC using the funds provided by the Government, NBA as well as through the Access and Benefit sharing project being implemented with GIZ and NBA. This will help in streamlining the functioning of the BMCs and would encourage the other BMCs in the district to follow suit.

This will involve direct engagement with BMC members on various operational aspects such as conducting meetings, maintenance of records, chronicling the knowledge related to the bio-resources of the area in the form of People's Biodiversity Registers (PBR) and implementation of the Access and Benefit Sharing provisions.

In this regard, Nodal officers were requested to propose two or three potential BMCs in their district that could be developed as Model BMCs. The indicative criteria for selection of Model BMCs are as follows:

- 1. Areas with substantial sourcing/trade of biological resources including NTFPs, medicinal plants for commercial utilisation (biological resources and commercial utilisation as defined in Section 2 of the BD Act, 2002).
- 2. Areas providing supplies to or with biodiversity-based businesses (industries or companies) for e.g., Pharmaceuticals, nutraceuticals, cosmetics, colours, enzymes, Oleoresins, extracts (viz. sea weed extracts, agar production using sea weeds).
- 3. Areas known for export of biological resources for use in pharmaceuticals, nutraceuticals, cosmetics, colours, enzymes, Oleoresins etc.
- 4. Areas that have potential to be declared as Biodiversity Heritage Sites (preferably focusing on agro, horti, livestock and wild biodiversity outside PAs and RFs)
- 5. Areas with active local communities showing considerable interest or initiatives in biodiversity related matters.

The tentative model BMCs proposed in each district is provided in Annexure 4.

The Board may approve action to be taken to select one BMC for each district from the list and take further action in this regard.

Agenda 6: Formation of Biodiversity Heritage Sites

In exercise of the powers conferred under Section 37(1) of the Biological Diversity Act, 2002, the State Government in consultation with the local bodies may notify areas of biodiversity importance (wild or cultivated/domesticated) as "Biodiversity Heritage Sites" under this Act. Biodiversity Heritage Sites (BHS) are well defined areas that are unique, ecologically fragile ecosystems - terrestrial, coastal & inland waters and marine having rich biodiversity with some special component as elaborated in the enclosure.

The potential BHS site could be private, community or government owned land / water body and the status of ownership will not change in case of notification as a Biodiversity Heritage Site. The BHS will continue to be managed by the present owner with assistance from the concerned Biodiversity Management Committee and the Tamil Nadu Biodiversity Board.

A detailed format and information on Biodiversity Heritage Sites (BHS) for the identification and declaration process of BHS has been sent to all Principal Secretaries of the stake holder departments, District Collectors, District Forest Officers and line departments besides ex-officio and Expert members of the board requesting them to identify and propose suitable sites as BHS in their District by using all available resources.

It is requested the Board may approve the formation of a Committee by the PCCF and Chief Wildlife Warden to examine the proposals for BHS and short list the sites for eventual notification by the Government.

Agenda 7: Issuing Compliance notices to the Companies for the implementation of BD Act.

Compliance notices were issued to several companies in connection with the implementation of the Biological Diversity Act, 2002 and Rules. The following provisions of the Act were brought to the notice of the Companies:

a) This is to bring to notice that the Tamil Nadu Biodiversity Board is implementing the provisions of the Biological Diversity Act, 2002, the Biological Diversity Rules, 2004, the Tamil Nadu Biological Diversity Rules, 2017 and Guidelines on Access to Biological Resources and Associated Knowledge and Benefits Sharing Regulations, 2014 in the State of Tamil Nadu.

- b) Section 3 and 7 of the Biological Diversity Act, 2002 mandates any person/s and entities referred therein to submit the prescribed form(s) along with fees for accessing biological resources and/or associated knowledge for purpose referred in Section 2(d), 2(f) and 2(m) to National Biodiversity Authority or Tamil Nadu Biodiversity Board as the case may be.
- c) Section 23 of Biological Diversity Act, 2002 Act read with Rule 15 of Tamil Nadu Biological Diversity Rules 2017 mandates the Tamil Nadu Biodiversity Board to regulate by granting approvals or otherwise requests for commercial utilization (Section 2(f)) or bio-survey and bio-utilisation for commercial utilisation (Section 2(d)) of any biological resources obtained from Tamil Nadu by Indians. Such applications from individuals, body corporates, associations or organizations referred in Section 7 and Section 24 should be in Form-I along with a fee of Rs. 10,000/- in favour of "Tamil Nadu Biodiversity Board" as prescribed in Rule 15 of the Tamil Nadu Biological Diversity Rules 2017.
- d) Section 40 of the Biological Diversity Act, 2002, provides exemptions to certain biological resources notified as 'normally traded as commodities'. However, such items are treated as 'normally traded as commodities' only when it is traded as a matter of common practice. This is dealt in Government of India notifications dated 7th April, 2016 and its amendment dated 7th November 2017.
- e) Section 55 to 59 of the Biological Diversity Act deal with the penal provisions for any omission /commission by individuals/companies which is in contravention of the above provisions.
- f) In view of the above, the companies and associates were informed to comply with provisions of the Act, Rules and related notifications and submit the prescribed Form-1 for accessing biological resources to National Biodiversity Authority or Tamil Nadu Biodiversity Board as the case may be. In this regard compliance notices have been issued to over 328 Companies.

Some companies have submitted Form 1 with requisite fees and several other companies have sought clarifications from the Board and the same are being processed.

Agenda: 8 International Biodiversity Day 2018 Celebrations:

The International Day for Biological Diversity 2018 was celebrated through a state level function on 22nd May 2018 at The Raintree Hotal, Anna Salai, Chennai. The theme for IBD 2018 'Celebrating 25 Years of Action for Biodiversity', was highlighted during the function. The Hon'ble Minister of Forests and the Chairperson of Tamil Nadu Biodiversity Board was the Chief Guest and addressed the audience. The Principal Secretary to Government of Tamil Nadu, Environment and Forests, the Principal Chief Conservator of Forests, (HoD), the Principal Chief Conservator of Forests and Chief Wildlife Warden of the Tamil Nadu Forest Department were on the dais and delivered their messages on the occasion. The importance of Biodiversity and its sustainable use was emphasized by the various speakers during the state level function. Further it is informed to the Board that for the first time the IBD celebrations have been held in all districts of Tamil Nadu in well organized functions. Painting, Quiz, poster and debate competition have also been held for the students along with awareness and cleaning campaigns.

Further the Hon'ble Minister of Forests and Chairperson, TNBB launched the logo and website (http://www.tnbb.tn.gov.in) of the Tamil Nadu Biodiversity Board. The coffee table book on the biodiversity of Tamil Nadu by the Tamil Nadu Biodiversity Board along with book on the Butterflies of Tamil Nadu written by Thiru. N. Satheesh IFS, were also released by the Hon'ble Minister of Forests.

Agenda 12: Proposals sent to the Government for Salary and Non salary expenditure

Proposals for Salary and Non-salary expenditure during 2018-19

- i) Government has sanctioned supporting staff for functioning of Tamil Nadu Biodiversity Board in the cadre of Administrative officer/Personal Assistant (Cadre post)-1, Superintendent-1, Assistant-3, Data entry operator/Console operator-1, Office Assistant-2. Out of the 8 sanctioned posts in the Board, only the Administrative Officer, Superintendent and one Assistant are in position as on 31.10.2018. The other posts i.e. 2 Assistants, Data Entry Operator/Console Operator and two office assistants have not been filled up till date.
- ii) A sum of Rs. 44.00 lakhs (Forty Four Lakhs only) is required for the payment of salary and allowances, pension contribution to the staff for the year 2018-19.
- iii) A sum of Rs.14.00 lakhs (Fourteen lakhs only) is required for the Non-salary expenditure of the Board for the year 2018-19.
- iv) A detailed proposal for Salary and Non-salary expenditure for 2018-19 was submitted to the Government vide PCCF and CWLW in WL4/23617/2018 dated 07.06.2018 for an amount of Rs. 57.00 Lakhs (Fifty Seven lakhs only) for sanction as grant in aid for the payment of salary and allowances and non-salary expenditure for the year 2018-19.

The Government in G.O. No. 316 E & F (FR.5) Dept dated 09.11.2018 has sanctioned Rs.43,12,065/- towards salary and non-salary expenditure during 2018-19. The funds sought for meetings of TNBB and Expert Sub-committees was not sanctioned by the Government.

This is brought to the notice of the Board for kind information.

<u>Proposals for reimbursement of expenditure incurred in previous years from NBA funds for salary and</u> administrative expenses

In the recent past, due to the inadequate allotment in the grant in aid to the Tamil Nadu Biodiversity Board, the Board was forced to make payment towards salaries and non-salary expenditure by utilizing the funds allotted to it by the National Biodiversity Authority for various other sanctioned activities of the Board. Hence, this payment needs to be reimbursed towards the funds allotted by the National Biodiversity Authority so that the sanctioned activities can be carried out smoothly. A detailed proposal for the total expenditure amount that needs to be reimbursed by the Government for the year 2017-18 to the funds of the Tamil Nadu Biodiversity Board was submitted to the Government vide PCCF and CWLW Ref. No. WL4/23617/2018 dated 07.06.2018 for an amount of Rs. 3,47,571/-(Rupees Three lakhs forty seven thousand five hundred and seventy one only).

This proposal has not been taken into account by the Government while issuing G.O. No. 316 E & F (FR.5) Dept dated 09.11.2018.

This is brought to the kind notice of the Board for information and the Board may kindly recommend to the Government for the additional sanction for 2018-19 as well as reimbursement of the additional expenditure incurred during 2017-18.

Agenda 13: Access and Benefit Sharing (ABS) Project with GIZ and National Biodiversity Project

The project in Tamil Nadu is strengthening the capacities of the Tamil Nadu Biodiversity Board, Biodiversity management Committees (BMCs) and commercial and Research user groups of biological resources and associated Knowledge. The project is working towards the effective implementation of ABS mechanisms under the Biological Diversity Act, 2002 in keeping with India's commitments under the Nagoya Protocol on ABS. The project in the last 18 months has supported several capacity development activities for various stakeholder groups such as line departments dealing with biodiversity and BMCs. It is proposed to expand the project activities to support 10 selected BMCs with start-up fund as per NBA guidelines. In addition, it is proposed to organise awareness workshops to cover all 385 Block level BMCs in all the districts to be conducted by the District Forest Officers/Wildlife Wardens (Nodal officers).

Submission of a proposal to GIZ India to obtain a grant of about Rupees forty lakhs may kindly be approved.

Agenda 14: Strengthening the Tamil Nadu Biodiversity Board with additional administrative and technical capacity

The day to day affairs of the TNBB is presently being managed by the Secretary at the level of APCCF and a few administrative staff. Unlike several other State Boards, TNBB does not have other technical capacity to assist in the functioning of the Board. 1049 BMCs have been established in the State and the PBRs for all 1049 BMCs need to be prepared as per the mandate of the Biological Diversity Act, 2002. The functioning of all 1049 BMCs also have to be monitored by the Board. In a recent case, the Hon'ble High Court questioned the Tamil Nadu Government regarding the formation of BMCs in all local bodies and preparation of PBRs.

The Board needs to be strengthened with Administrative, Technical and Scientific officers and staff to effectively function and deliver the mandate as per the Biodiversity Act and Rules. Hence the Board may approve the preparation of a detailed proposal to be submitted to the Government in this regard.

This may kindly be approved.
