From the Principal Chief Conservator of Forests and Chief Wildlife Warden letter No.WL4.8702/2004, dated 6.8.2012 and 22.10.2012.

ORDER:-

The Principal Chief Conservator of Forests and Chief Wildlife Warden in his letter read above has stated that the financial grants sanctioned to Tamil Nadu Biodiversity Board by the National Biodiversity Authority, Chennai and the State Government are being deposited and maintained in Tamil Nadu Biodiversity Board's account and operated by the Principal Chief Conservator of Forests and Chief Wildlife Warden. But, the National Biodiversity Authority, Chennai has stated that any financial grants received from National Biodiversity Authority should not only be operated in the Saving Bank Account in the name of Tamil Nadu Biodiversity Board but it should be operated independently by the Member Secretary of the Board.

He has therefore requested the Government to issue necessary orders to open Saving Bank account in the name of Tamil Nadu Bio Diversity Board operated by the Member Secretary of the Board and to close the existing account operated by the Principal Chief Conservator of Forests and Chief Wildlife Warden in the name of Thiru R. Sundararaju.

3. The Government after careful examination accept the request of the Principal Chief Conservator of Forests and Chief Wildlife Warden and direct to open a Saving Bank account in the name of Tamil Nadu Bio Diversity Board operated by the Member Secretary of the Board.


