The Additional Chief Secretary, Environment and Forests Department conducted a consultation meeting with the Tamil Nadu Biodiversity Board on 04.11.2020 and it was decided that a Nodal officer from Agriculture Department may be appointed to co-ordinate with the Tamil Nadu Biodiversity Board for implementation of Biological Diversity Act 2002 in entire State of Tamil Nadu.

3. The Government after careful examination nominate the Additional Director of Agriculture (Research) as Nodal officer to assist the Tamil Nadu Biodiversity Board
